MOTION by Travis to approve Special Meeting #2 May 26, 2020 minutes, Alan seconded. Motion carried 4-0-1(Lindsay abstained)

MOTION by Lindsay to approve Payroll and Payroll tax & benefits 5C and Payables 6A, Travis seconded. Motion Carried 5-0

IV. APPROVAL OF AGENDA:

MOTION by Lindsay to approve the agenda as written, seconded by Jay. Motion carried 5-0.

V. AGENDA ITEMS:

Megan Crosley is the new HUB Director and would like to have a couple of fundraisers for the HUB on July 9th and July 30th. A motion by Jay to approve 3 parking stalls in front of the HUB to be blocked off on July 9th and July 30th for their events, seconded by Travis. Motion carried 5-0

Randy Dallke with Atmos informed the Council that Atmos will be working in the alley by the Post Office within the next 30-60days.

Rachel asked about a couple of safety concerns for the amount of people allowed in the pool. She is to report back to the Council on the 29th of June on how the pool is running.

A motion by Travis to hire Charles Major as a lifeguard for \$7.50/hr, seconded by Lindsay. Motion carried 5-0.

Jay went over the plans for the 4th of July for the 4th Fest Committee. A motion by Travis to approve closing the park to others besides the 4th Fest Committee and Volunteers on the 4th of July, seconded by Lindsay. Motion carried 5-0.

Reports from Standing Committees:

1. **Water (Gfeller, Gillen)** – nothing to report.
2. **Streets and Alleys (Spencer, Wilson, Reynolds)** – A motion by Travis to approve the barricade request for the 4th of July Parade, seconded by Lindsay. Motion carried 5-0.
3. **Sanitation (Gfeller, Hutchison)** – Clean up dates will now October 3 and November 21
4. **Lights (Gfeller, Gillen)** –the field lights at the park will be shut off at 10pm on the 4th and won't be turned back on that night.
5. **Fire (Reynolds, Hutchison)** – nothing to report.
6. **Park and Swimming Pool (Spencer, Hutchison, Gillen)** –nothing to report.
7. **Building (Gfeller, Reynolds)** – the small shed behind the Round House was broken into at some point. A Police report was made. Check with Lloyd on what all we will need to continue to use GotoMeeting

8. **Finance and Ordinance (Spencer, Wilson, Hutchison)** –
A motion by Travis to get a \$500 limit credit card for the use of the Pool supplies, seconded by Lindsay. Motion carried 5-0.
A motion by Lindsay for single swim pass to be \$30 this season only, seconded by Travis. Motion carried 5-0.
A motion by Travis for Fireworks shooting times to be as follows:
July 1,2 & 5- 8am-10pm
July 3 & 4- 8am- Midnight
Seconded by Alan. Motion carried 5-0.
9. **Economic Development Committee (Gfeller, Hutchison)** –
July 20th at 7pm meetings will start back up. The city did not receive the grant but Marion County did.
10. **Personnel (Spencer, Wilson, Reynolds)** – A motion by Travis to send Allen to the Competent Person Trenching/Excavation and Confined Spaces on July 8 & 9 in Newton for the cost of \$180 and to include meals, seconded by Jay. Motion carried 5-0.
A motion by Travis to hire Brandon Cassity for \$12/hr pending a drug/alcohol test and his acceptance of the job, seconded by Alan. Motion carried 5-0.

Report from the Mayor- Applying for the Covid grant was a learning experience and will be good help with moving forward on the Park Project.
